### Statement to the Congressional Human Rights Caucus on Behalf of the Indo-American Kashmir Forum (IAKF), an Organization Dedicated to the Protection of Human Rights of Minorities in Kashmir

We are not professional lobbyists or media consultants, nor do we have the kind of money to pay the public relations companies who are campaigning on behalf of our adversaries. Unlike our opponents, the President of our Forum does not travel to sponsoring countries to update them on the status of the campaign - the media war - being fought in this country. We have no fancy brochures or pamphlets, only the facts that cannot be suppressed any more. We have no sponsor other than our conscience and our pain for our loved ones, our close relatives, who are suffering a thousand deaths as we speak today.

We are talking about the inhabitants of Kashmir who created the civilization in that beautiful land around 3000 B.C., who contributed to the glory of Hinduism and Buddhism, and when the era came to accept the Islam in 1300's, did it with passive acceptance and open tolerance. Kashmiri Pandits (Hindus) paid a dear price for their humanism then, resulting in the survival of only eleven Hindu families in the entire valley by early 1400's, but kept the hope and faith that things can only get better, not worse. The concept of "Kashmiriyat" was born, which simply stated means that Kashmiri Pandits and Muslims have a rich tradition of religious tolerance and common cultural values that allows them to co-exist peacefully.

This in effect became the crux of that idea behind "Naya Kashmir" (new Kashmir) that Kashmiris of all denominations supported at the time when political choices had to be made in the Indian subcontinent in 1947. The essence of Kashmiriyat is what made Kashmiri Pandits feel secure in the valley inspite of the early signs of terrorism which began to raise its ugly head in February 1986 when a number of Hindus temples (places of worship) and homes were destroyed in South Kashmir. Unfortunately, the tolerance and moderation shown by the Hindus became their curse. Drawing inspiration and support from their role models in Pakistan, Saudi Arabia, Afghanistan and Iran, a new breed of Kashmiri militants and terrorists took hold of the valley and brought death and destruction to Kashmiri Pandits.

The survivors of the holocaust still speak in terror of the night of April 4, 1990, when all the mosques simultaneously broadcast an audio tape asking people to fight jihad against India and threatened "Hindu infidels" to leave the valley or face dire consequences. Subsequently, on April 14, 1990 the "Alsafa" news daily published a statement stating, "Pandits, responsible for harassment of Muslims, must leave within two days". Imagine the 95% Muslim majority feeling threatened by the 5% Hindu minority!

Even today, the abuse of the human rights of Kashmiri Pandits by the Islamic terrorists in the valley continues unabated. We are talking of killings, abductions, brutality, people driven from their homes and lands, vacant homes fire bombed and the degeneration of an entire ethnic community to a second class citizenship in their own land. We are talking of destruction of a 5,000 year old culture, that contributed to Hinduism, Buddhism, Islam and Kashmiriyat. We are talking of an endangered human species, already decimated to a small size (about 280,000 brave souls), which is on its way to complete extinction.

This paradigm will not be interrupted unless the World understands what is really happening in Kashmir today. It will not change unless you, the members of the Congressional Human Rights Caucus, step forward and ask our adversaries, "Why did you not tell us the whole story?" We are here to tell that story.

#### **MEMORANDUM**

on

#### Human rights Violations of Kashmiri Hindus

Your Excellency,

We, the Kashmiri Hindu tiny minority in the overwhelmingly Muslim-majority Kashmir region of the Jammu and Kashmir State of India, have the following to submit.

The tangled Kashmir situation and the exercises to solve it are nearly 45 years old. The United Nations Organisation (UNO) has been involved in it ever since Pakistan attacked the State, and India, to which it had acceded at partition in 1947, took the matter before the UNO.

The UNO Resolutions on the subject are clear and well known. In brief, these urged upon the aggressor country Pakistan to vacate the aggression, to resettle the people displaced by that aggression and handover the occupied part to the J&K authorities.

The Resolutions further envisaged a plebiscite to be held after normally had been thus restored.

Pakistan which had accepted to take these first steps failed to honour its own promises all these two score years and wwre. The UN Resolutions have thereby been rendered by it ineffectual, in fructuous and irrelevant.

In the mean time Pakistan has all the while kept the pressure of aggression on, in one way or another, e.g. the 1965 war against India, or the the 1971 Bangladesh war for freedom from Pakistan when the latter extended the conflict from the eastern to the 1500 Km away western front along Kashimir & Punjab. In 1972, Pakistan signed Simla agreement with India. Under this agreement Pakistan had undertaken to settle all disputes only through bilateral discussions.

Nevertheless flouting all this it continued to sharpen its fangs and turn to many activities of subversion and promotion of internal disorder within the Kashmir Valley.

All this has culminated in the three year old Islamic fundamentalist terrorism in the Valley of Kashmir. As is well known the world over, the Kashmiri Hindus had been singled out as target for the orgy of killings, rape, loot, arson, vandalism, and untold terror and torture.

The small innocuous, unarmed and traditionally peace lovinghighly educated and cultured society has been subject to such acute abuse and inhuman violence as to push it to the edge of extinction. They were terrorised and tortured and filled with paralysing fright, their properties seized or destroyed, their jobs snatched, their avocations devastated, their places of worship desecrated. This was of the proporations of agenocide, a holocaust and a blinding blankness such as humankind may never have experienced, except perhaps the jews under Hitler's Germany.

The Kashmiri Pandits fled their mill@nia-old flourishing homes and hearths in utter disarray with hands empty but hearts and minds filled with benumbing horror. They have since been living miserable lives in sub-human conditions in hurriedly put up refugee camps in Jammu and elsewhere in India.

The Appendix attached gives in broad outline a measure of the sufference of this proud and productive minority. They have enriched their birthland as well as many countries with their hard, honest efficient and very special skills and services. Yet back home, this very community has been reduced to be destitute, sick and starving. They are living out their days in utter lack of dignity, privacy, gainful employment and the minimum needs for bare survival. And now they face the grim prospect of losing also their right to contest and vote, if the authorities carry out their plan of holding elections to the State Legislature, disregarding the basic rights of more than 300 thousand people thrown out of their home land.

You would thus observe, Sir, that all the human rights enshrined in the UN Charter & in the Universal Declaration have been violated and snatched from this Hindu minority and are being trampelled under foot all day, everyday by Pakistan and Pakistan armed, trained, aided and abetted saboteures, terrorists and fundamentalist zealops and outright bandits.

It is a traversty of justice, fairplay and truth that no world body claiming to secure the rights of people has ever taken note of the human tragedy which has brought down 300,000 of this community to lick dust and dirt in the so-called camps which are infested with disease and reptiles etcl.

- 2. More than 14,000 houses of Hindu Minority have been looted so far.
- 3. More than 3,000 houses have been put to torch upto this day.
- 4. Hundreds of Or hards and farms belonging to Hindu minority have been extensively damaged.
- 5. Hundreds of Hindus have been abducted so far. Some of those who were release in exchange of jailed terrorist have all most lost their balance of mind.
- 6. Under the order Islamic fundamentalist organisations all people pursuing any vocation in connection with fine arts like dance, drama, singing, sculpture were asked to give-up these profession as they are not allowed in Islam. Beautiparlours, Beer or liquor bars and video clubs were close forcitally by the terriorist. This resulted in 2,700 People losing their jobs and source of livelihood.
